#### President's Message:

The news about our fund's investment return for the first quarter of our fiscal year was very positive. Usually, the first quarter following September 30th, is very slow and many times shows a loss. But, the report at the December pension board meeting showed the investment return was a positive 3.2% at the end of November and a positive 4.3% by the meeting date of December 18th. Of course since then, there has been escalated conflict in the middle east which will certainly show in the stock market. Also at the December pension board meeting the actuary gave a report on their Stochastic Projection Study. This is just a fancy name for a "guess" on how well the fund will perform through 2047, based on past performance. The results of the study determine what the Assumption Rate should be, and in turn determines what the city and employee contribution rate will be. The current assumption rate is 8.5% and the actuary recommends it remain the same. So, the board voted to take no action to change it at this time. A side projection that retirees would be interested in was the PRAA Insolvency Probability. That is, what's the chance of the COLA fund going broke in that same time frame? The projection showed 0% chance through the year 2033 and only 7% chance through 2047. I guess we're safe for awhile.

At the December retirees luncheon I informed your executive board that my current term as your president expires this year, and I would not be running for re-election. This is the second time I've served as president, as well as vice president and treasurer in the past. It's been an honor that you've placed your

trust in me, and a privilege to have served you.

The meetings will be held on Tuesday, January 28, 2020 and Wednesday, January 29, 2020 at the Tampa Convention Center.







#### COMMUNICATIONS

Today (12/30/19) at our end of the month luncheon (also end of the decade luncheon) I was asked about "communications" with members.

It dawned on me, we do have pretty good communications system, but in some cases, not enough.

FIRST: The primary communications happens when you attend a meeting, (board, luncheon, quarterly or even pension board meetings). This is the best way.

The website allows "read the message or post the message" but not direct two-way communications. You need to contact me to get and ID and Password, please note: (we will register any Tampa Fire or Police person wishing to communicate on our message board, great for a person running for Pension Officer). The Facebook is very similar, you have online communications for reading and posting and you also have private messaging, but only for other Facebook members. Both of these methods work pretty well.
